ORDER

- 1. Vide paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2022–23 from colleges for the courses affiliated to the University. In response to the same, Principal, Nangelil Ayurveda Medical College, Kothamangalam vide paper read (2) above has submitted application for the continuation of provisional affiliation for the year 2022–23 with necessary documents and remitted requisite fee.
- 2. Subsequently, University carried out an inspection at the college to assess the facilities available for conducting UG BAMS Course with 60 seats and the inspection commission submitted the report vide paper read (3) above. The Scrutiny committee in its meeting held on 27/04/2022, verified the inspection report and vide paper read (4) above, and pointed out some deficiencies and the same were intimated to the college vide paper (5) above for rectification.

- 3. In response to this ,the Principal Nangelil Ayurveda Medical College, Kothamangalan submitted a compliance report along with an affidavit read (6) above and same was placed before the Scrutiny committee in its meeting dated 13/09/2022. After detailed verification of complaince report, scrutiny committee recommended to grant **Conditional Continuation of Provisional Affiliation** to Nangelil Ayurveda Medical College, Kothamangalam for conducting UG BAMS Course with 60 seats for the academic year 2022–23.
- 4.The aforesaid matter was placed in the 71 st meeting of the Governing Council for appropriate decision. Accordingly the Governing Council vide decision read (7) above decided to grant Conditional Continuation of Provisional Affiliation to Nangelil Ayurveda Medical College, Kothamangalam to conduct UG BAMS course with annual intake 60 seats, subject to the receipt of Letter of Permission from the Ministry of AYUSH for the academic year 2022–23.
- 5.The Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India vide paper (8) above has granted Conditional Permission to Nangelil Ayurveda Medical College, Kothamangalam, Ernakulam , Kerala (AYU0105) to conduct UG BAMS course with annual intake 60 seats for for the academic session 2022–23, under section 28 of NCISM Act 2020.
- 6. In this circumstances, sanction is hereby accorded to implement the decision of the Governing Council and to grant Conditional Continuation of Provisional Affiliation to Nangelil Ayurveda Medical College, Kothamangalam for the academic year 2022–23 for conducting UG (BAMS) course with an annual intake of 60 seats during the academic year 2022–23, subject to the following conditions:
- i) Departmental wise recommended bed occupancy and OP Patients in the ratio 1:2 per student shall be maintained which shall be verified by the university through surprise inspection.
- ii) If the deficiencies pointed out by the scrutiny committee are not rectified, the Conditional Continuation of Provisional Affiliation now granted shall cease automatically and the loss suffered by the students admitted, as determined by the University shall have to be compensated by the college.
- iii) An Undertaking to this effect shall be submitted in stamp paper worth Rs.200/- by the college within seven days from date of this Order, failing which the order now issued will be treated as null and void.
- 7. The college shall also adhere to the general conditions detailed below.
- i). The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG/PG Degree/Diploma courses in Ayurveda during 2022–23 vide letter read (8) above.
- ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- iii) In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

- iv) Affiliation granted is strictly provisional and only for the academic year 2022–23. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- v) The College should remit balance annual administration fee fixed for UG/PG course for the academic year 2022-23, if applicable.
- vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
